Adv. Ms. Shweta Singh submits that appellants have filed additional affidavit and served copy of the same to other side. Adv. Ms. Padma Chinta submits that the respondent in appeals at Sr. Nos.18 to 23 have not received copy of the same. The respondent in appeal at Sr. No.17 submits that he has received copy of the same on yesterday by email. Adv. Ms. Singh undertakes to serve copy of additional affidavit to rest of the respondents.

2] Adv. Mr. Gauraj Shah submits that the appellant has filed additional affidavit in all matters with regard to computation of amount of interest and served copies of the same to other side. Adv. Ms. Padma Chinta submits that they have not received copies of the same.

4] Adv. Ms. Padma Chinta submits that in the following appeals the respondents have calculated interest from the date of possession i.e. from December 2012 and March 2017 till 23.6.2023 and amount of interest comes to –

5] Despite ample opportunity, the appellant has failed to file affidavit with regard to computation of interest. Adv. Mr. Shah submits that as per impugned order, the promoter is entitled to set off on interest amount against the outstanding dues payable by the allottees. He further submits that the promoter is supposed to pay interest on the actual amount i.e. excluding amount paid towards the stamp duty, taxes, etc. Besides the promoter is also entitled to claim benefit of "moratorium period" as mentioned in Notification dated 2.4.2020 and 18.5.2020 issued by the MahaRERA. It is significant to note that till date the appellant have not filed affidavit of computation of amount.

6] In order to give fair and reasonable opportunity appellant to file additional affidavit with regard to computation of interest last chance is granted, failing which Tribunal will consider the submissions of respondents and necessary orders will be passed
