## Misc. Application No.584/2023

Advocate Ms. Shivani Shukla submits that rejoinder from Nonapplicant No.2 on Misc. Application No.584/23 has been received only

yesterday.

2] Advocate Ms. Asmita Rajbhar, learned counsel for Non-applicant No.2 submits that due to inadvertence, Non-applicant No.2 could not appear. She initially submitted that the Appeal and the intimation of Notice

for appearance was not received and the link for meeting was also not received. Therefore, it is only just and fair that the Non-applicant No.2 be heard and be granted a liberty to controvert the contentions made in the Appeal.

2] Advocate Ms. Shivani Shukla, learned counsel appearing for Applicants vehemently opposed the captioned Misc. Application by submitting that the Application itself in para 7 clearly mentions about the Notice of the hearing alongwith Appeal, which were served and only link for the meeting was not been provided to Non-applicant No.2. Advocate Ms. Shivani Shukla, vehemently opposed by further submitting that it is unlikely that Non-applicant No.2 in Appeal will not receive meeting link and therefore, captioned Misc. Application be rejected.

3] Perused.

4] It appears that the Non-applicant No.2 has not appeared due to inadvertence, and it will be in the interest of justice that the Non-applicant No.2 be allowed to participate in the Appeal proceedings and accordingly, we are of the view that the captioned Misc. Application be allowed and we proceed to pass the following Order as follows.

#### ORDER

- 1. Misc. Application No.584/2023 stands allowed.
- 2. Ex-parte Order dated 28th July, 2024 is recalled subject to cost of

Rs.10,000/- to be paid directly to the account of the Complainants within two weeks.

3. Payment of costs is condition precedent.
