1] Learned C.A. submits that there are multiple complaints filed by the Appellant Promoter as well as by Allottees and the common order dated 20<sup>th</sup> June 2023 has been passed by the learned Member, MahaRERA. He further submits to file and circulate copy of all the relevant orders mentioned therein alongwith the chronology of the events by tomorrow.

2] Compliance of proviso is statutorily mandatory, without which Appeal cannot be entertained for consideration on merits. In the instant case, the order for 43(5) has already been passed on way back on 30<sup>th</sup> October 2023, another opportunity was also given to appellant on 23<sup>rd</sup> January 2024, again on 21<sup>st</sup> March 2024 and again on 2<sup>nd</sup> May 2024.

3] However, compliance of the proviso has still not been completed and the matter is lingering only for want of compliance of proviso for such a long time.

4] However, in the interest of justice last opportunity is given to appellant to comply with proviso failing, which all these Appeals filed by appellant promoter along with connected Applications will be dismissed without any further reference.
