- 4] Matter are kept back.

- 5] Report filed by Appellant have been located.
- 6] Learned counsel confirms that compliance report in pursuance to order dated 31.10.2023 passed by this Tribunal in the last date have been complied with in all the three appeals.
- 7] In view of the compliance of the order dated 31.10.2023 and compliance of the Proviso to Section 43(5), and in view of the execution of the order is already listed before the executing authority on 08.01.2024, learned counsel for Appellant promoter seeks to stay the impugned order dated 30.06.2023 passed by MahaRERA.
- 8] In view of the deposit of the requisite amount in pursuance to order dated 31.10.2023 of this Tribunal towards the compliance of the proviso directly in the Account Section of this Tribunal, Appellant is further
