Adv. Ashish Fule submits that he has instructions to appear on behalf of Non-applicants and seeks time to file vakalatnama and reply to Misc. Application No.719/23.

2. He further confirms that Misc. Application of delay has been received but the appeal sets has not been received.

3. Adv. Vikramjit Garewal submits that appeal sets were served a few days ago. However, he undertakes to re-serve the same again.

IN M.A. No. 719/23:

4. Adv. Vikramjit Garewal submits that this application has been filed with delay of five days beyond the prescribed permissible period and the

delay of five days happened because the signatory to the appeal was travelling.

5. The delay happened unintentionally, is not deliberate and on account of bona fide reasons. Accordingly, urged to condone the said delay of five (5) days.

6. Adv. Ashish Fule upon instructions submits that he has instructions to appear on behalf of Non-applicants and seeks time to file vakalatnama and reply to Misc. Application/appeal.

7. Adv. Ashish Fule along with Non-applicant no. 2 jointly submits that Non-applicant has no objection to condone the delay of five days in filing appeal by the Applicant. They further submit that Applicant be directed to deposit the entire amount as pe the impugned order dated 30th June 2023 along with interest till the date of deposit.

8. Non-applicant has no objection to condone the delay.

9. In view of no objection, Misc. Application No. 719/23 is allowed.

10. Delay is condoned.

11. No order as to costs.

14. Adv. Vikramjit Garewal further submits that the Respondents have filed an execution application of the impugned order dated 30th June 2023 passed by MahaRERA before the Executing Authority/MahaRERA and the

order in execution is already reserved for order after hearing on 11th Dec. 2023. In view of urgency of the matter, the Appellant has filed the Misc. Application No. 594/23 for the stay to stay the effect, implementation and execution of the order dated 30th June 2023 by MahaRERA.

Application has been filed by the Promoter and therefore, the 17. Appellant/Promoter needs to first comply with the statutory requirement of the proviso to section 43(5) of the 2016 Act.

Compliance of proviso being statutory and mandatory before the 18. appeal is entertained, Appellants are directed to pre-deposit the entire amount as per the impugned order dated 30th June 2023 passed by MahaRERA along with interest till the date of the deposit in the Tribunal towards the compliance of the proviso.

Adv. Vikramjit Garewal upon instructions undertakes to pre-deposit 19. the entire amount as per the impugned order within six weeks from today. Stand over to 01st Apr. 2024 for compliance, vakalatnama and reply 20. of appeal of the Non-applicant.
