2. Advocate Mirchandani for Pankaj Chawla submits that he has produced couple of documents in its supports and submits that the matter was closed for order on 15<sup>th</sup> October 2018 after hearing both the parties by MahaRERA vide roznama on page No.222 in Appeal No.52603.
