- 2] Perused order dated 04.08.2023.
- Misc. Application No.480/2022 has been filed for restoration of captioned appeal by condoning the delay on the grounds set-out in Misc. Application No.497/2022.
- 4] Misc. Application No.480/2022 for restoration of appeal is filed on 24.05.2022 against the order dated 18.12.2020.
- 5] Appeal was dismissed on the ground of non-appearance of Applicant/appellant even after providing sufficient opportunities vide order

- At this stage, Advocate Mr. K. K. Saswade joined the conference and submits that appeal was filed on 18.01.2020 and office objection was rectified on 24.02.2020. The e-mail sent by this Tribunal was not received by the applicant, apparently the email went to spam of the email of applicant and thereby, the applicant was totally unaware of the proceedings.
- 9] He further submits that after dismissal of the appeal on 18.12.2020, and immediately thereafter, the Covid-19 pandemic broke out and as a result of that, delay has happened. Therefore, sought for condonation of delay by filing Misc. Application No.497/2022 and the appeal be restored to the file.
