- 6] Learned counsel for Non-applicant further submits that there is certain amount due and outstanding as per the judgment decree.
- In the peculiar facts and circumstances of the case, despite clear orders of this Tribunal, Non-applicant despite having sufficient means has not complied with the various orders of this Tribunal to satisfy the judgment decree. Accordingly, we are of the opinion that coercive measures including for attachment of properties mentioned in the purshis including freezing of the bank accounts as mentioned on page nos. 692 onwards is imperative for compliance of the orders.
- Registry is accordingly directed to issue recovery warrant for attachment and freezing of bank accounts following the standard procedure in prescribed formats.
- 9] Accordingly, captioned Misc. Application No. 713/2023 stands disposed of as above.
