- that all the captioned three appeals including other connected appeals filed by allottees are also listed for final hearing on 30<sup>th</sup> November, 2023 and it is the promoter who has been seeking time in the recent few hearing dates and as a consequence of that, appeals are not getting finally heard.
  - In the peculiar facts and circumstances of the case, more particularly the Proviso to Section 43(5) of the Act has satisfactorily been complied with by the appellant promoter, we are of the view that there is no impediment in providing the interim relief by granting stay to the execution of the impugned order passed by MahaRERA, on the condition that appellant promoter will not seek any further adjournment for the final

hearing already scheduled on 30.11.2023 and we proceed to pass the order as follows: -

#### **ORAL ORDER**

- (a) Execution of the impugned order dated 11<sup>th</sup> November 2019 passed by MahaRERA is stayed.
- (b) In view of above, Misc. Application Nos. 463/2020 and 464/2020 stands disposed of on above terms.
- (c) Accordingly, praecipes are disposed of.
- (d) No costs.
