- 2. By this application, Respondent no. 2 is seeking to set aside the exparte order dated 14th Sept. 2022 passed by this Tribunal wherein appeal has proceeded against the Respondent no. 2.
- 3. Adv. Jayprakash Tiwari submits that even though the Appellants have informed that the appeal has been filed, he was never informed about any date of hearing in the appeal proceedings.
- 4. In the absence of the intimation about the date of hearings, Respondent no. 2 could not appear earlier. He came to know about the

date of hearing only after the receipt of the Tribunal letter dated 16th Jan. 2023 and he appeared on 10th Feb. 2023.

- 5. Adv. Vandana submits that Appellants have served the appeal sets. Respondent no. 2 was not informed about any date of hearings.
