- 22. Being withdrawn, the captioned Execution Application No. 3/2022 stands disposed of as settled and withdrawn.
- 23. No costs.

#### IN Misc. APPLICATION NO. 539/23

24. Adv. Yunus Vakharia submits that his Misc. Application has been filed in pursuant to the amicable settlement among the parties for withdrawal of among of Rs.24,39,617/- along with accrued interest if any which were deposited in pursuant to the order of the Hon'ble Bombay High Court dated 21st Mar. 2023.

25. Mr. Anup Rath submits that he has no objection to the Applicant/Promoter for withdrawal of the amount along with accrued interest if any in view of the amicable settlement among the parties.

26. In view of above, Applicant/Promoter is permitted to withdraw the said amount of Rs. 24,39,617/- along with accrued interest if any as and when the formal request is made to the Tribunal.

27. Ld. Registrar is directed to take further steps to permit the withdrawal of the said amount as and when the request is made following standard procedure.
